6. SPONSOR agrees not to make any sound or video recording or reproductions of the concert without written permission from the ARTIST.

7. CANCELLATION: The ARTIST is not bound to this agreement if the SPONSOR fails to honor all conditions herein. The SPONSOR will still be obligated for the honorarium and travel, lodging and meals as applicable. SPONSOR CANCELLATION - all deposits are non-refundable. 50% of honorarium is due to the ARTIST if cancellation occurs 60 days or less prior to concert date. 100% of honorarium if SPONSOR cancels with less than 30 days notice. Cancellation notices must be in writing, postmark will serve as date.

8. In the event of sickness, injury, or accident to ARTIST, or if a performance is rendered impossible due to emergency beyond control of ARTIST, including weather conditions, it is understood and agreed to that there shall be no claim for damages by SPONSOR. In the event of such non-performances for any reasons listed in this paragraph, ARTIST will make every effort to reschedule the concert.

9. PROGRAMMING-The exact program of the ARTISTS selections will be decided in joint consultation, with the ARTIST having final decision.

SPECIAL PROVISIONS

A. ARTIST shall be included in 100% of all advertising, lights, displays, radio, marquees, programs and any and all other advertising and publicity media.

B. Should inclement weather render outside performances impossible or not feasible, SPONSOR shall provide alternative location for performance or SPONSOR shall nevertheless pay ARTIST full compensation as provided herein. ARTIST will have final decision in weather related decisions.

C. All opening acts shall be subject to ARTIST'S approval.

D. IF APPLICABLE ARTIST'S RIDER ATTACHED IS HEREBY MADE A PART OF THIS CONTRACT.
